

Privacy Policy

This privacy statement ("Privacy Statement") applies only to the www.cas.net.my web site (or the "web site"), which is provided by CAS Malaysia (also referred to below as "we", "us", "our" or "CASM") and not to the various separate web sites for each location where CAS is present to which the CAS Malaysia website redirects you.

By using cas.net.my and submitting any personal information to us, you agree to the use by us of your personal information in accordance with the terms of this Privacy Statement.

Consent to Processing

By providing any personal information to this web site, you fully understand and unambiguously consent to the transfer of such personal information, and the collection and processing of such personal information provided, to the extent permitted in this Privacy Statement.

Please note that the other country or specific websites contained within the www.casglobal.world website, to which you may be directed by the www.cas.net.my website, are provided by the applicable CAS member firms or related entities managing them and are not the responsibility of CASM. Such websites, as well as other websites that may be linked to this website, are not governed by this Privacy Statement. We encourage visitors to review the privacy statements of www.casglobal.world as well as each of these other web sites before disclosing any personal information.

What personal information do you collect when I visit cas.net.my?

We do not require registration for access to cas.net.my, but if you participate in any of the activities or services offered by cas.net.my, we will collect the personal information that we need in order to provide you with those services, such as your name, job title, email address, employer's name, and telephone number.

We do not collect sensitive personal information from you from cas.net.my. Sensitive information includes data relating to: race or ethnic origin; political opinions; religious or other similar beliefs; physical or mental health; sexual orientation or criminal record. Where you provide sensitive personal information to us voluntarily we will assume that we have your explicit consent to use that information in connection with the purpose for which it has been provided.

Technical Information

When you visit this web site, we may collect technical information such as your IP (Internet Protocol) address, details of the pages you visit on cas.net.my, other pages you visit on the Web, and which browser you used to view cas.net.my.

This web site collects standard internet log and technical data to measure and improve the effectiveness of this web site, to help diagnose problems with our server, to administer this web site, to see where web site traffic is coming from and to identify our users. We may also collect other information via cas.net.my, such as web site usage activity and preferences, also known as demographic or profile data. When do you collect personal information through cas.net.my?

We collect personal information from you in the following circumstances:

- when you subscribe to any of our insights
- when you register to attend an event
- when you enter a discussion forum
- when you contact us to request further information

We collect the minimum amount of information to enable us to deal with your request. We will indicate where the provision of information is voluntary or compulsory. We would normally only request additional information to enable us to provide the most appropriate response to your request.

[Your Rights](#)

You have the right to request access to the personal information, that you have submitted through cas.net.my, update or correct your details, opt out of receiving other information from CAS or request that your personal details are deleted from our systems at any time by e-mailing enquiry@cas.net.my. We will treat all such requests in accordance with applicable local law and standards.

If you would like to opt not to receive communication e-mail from us in the future, you may let us know by sending us an e-mail to enquiry@cas.net.my stating the e-mail address you wish to be removed from our mailing list. However, your option not to receive communication e-mail shall not preclude us from corresponding with you, by e-mail or otherwise, regarding your existing relationship with us.

[Will you provide my information to a third party?](#)

We may contract with other companies or individuals to deal with your enquiry or to otherwise operate this web site or our business activities. We may give such companies access to your personal information in connection with those purposes on our behalf. We may also share your personal information with other member firms within the CAS Global network provided that this is consistent with the basis on which we have collected your personal information.

We do not provide information to third parties for their own marketing purposes and we do not undertake mailings for third parties.

We may, as a result of a sale, merger, consolidation, change in control, transfer of assets, reorganization or liquidation of our company (a "Reorganization Event"), transfer, sell or assign your personal information to third parties involved in the Reorganization Event.

We keep your Information only for the period required for fulfilling your request and will delete it in accordance with our data retention policies.

[Is my information secure?](#)

We have implemented generally accepted standards of technology and operational security to protect personal information from loss, misuse, alteration or destruction. We require all employees and principals to keep personal information confidential, and only authorised personnel have access to this information.

[International Transfers](#)

The data and site of cas.net.my is hosted on the server managed by supplier inside Malaysia. You acknowledge that in order to provide services to you via cas.net.my we may need to transfer your personal information outside Malaysia, including to countries that may not provide a level of protection of personal information that may be regarded as equivalent to that afforded under Malaysian data protection legislation.

[Cookies](#)

This web site is intended to provide general information on the CAS network and the professional services and solutions provided by the CAS Global member firms around the world.

We gather information from users of this web site automatically and when you decide to provide us with information, for example, when you complete a form on www.cas.net.my. This information is treated with confidence, and is only used by CAS as per the terms of the Privacy Statement.

We may use "cookies" to keep, and sometimes track, information about you.

Cookies are small text files which are downloaded to your computer or mobile device when you visit a web site or application. Your web browser (such as Internet Explorer, Mozilla Firefox or Google Chrome) then sends these cookies back to the web site or application on each subsequent visit so that they can recognise you and remember things like personalised details or user preferences. Cookies do not damage your system. You can reset your browser so as to refuse any cookie or to alert you to when a cookie is being sent.

To improve your experience and to make our service to you better we use cookies for the purposes of system administration and analytics of our web site. This gives us information about the number of visitors to different parts of our web site.

CAS does not share this data with third parties. Each browser is different, so check the 'Help' menu of your particular browser (or your mobile phone's handset manual) to learn how to change your cookie preferences.

Most modern browsers will allow you to:

You should be aware that any preferences will be lost if you delete cookies. This includes where you have opted out from cookies, as this requires an opt-out cookie to be set. Also, if you block cookies completely many web sites will not work properly and some functionality on these web sites will not work at all.
